Boarding Policy and Disclaimer

Diamond in the Ruff Spa LLC. pledges to give appropriate care to all boarded pets.
I certify that my dog is current on all vaccinations, as required by Diamond in the RUFF Spa LLC,
and that my dog has not bitten anyone within the last 10 days.

I certify that in the unlikely event that my dog is injured by another dog I RELEASE Diamond in
the RUFF AND ITS AGENTS FROM ANY LIABILITY FOR SUCH INJURY.

If my dog injures another dog at Diamond in the RUFF, I will be solely responsible for any injury
to the other dog as well as my own dog and I RELEASE Diamond in the RUFF AND ITS AGENTS
FROM ANY LIABILITY FOR SUCH INJURY.

Should any non-life threatening medical issue arise, I understand that Diamond in the RUFF Spa
LLC. will attempt to reach me at first and then as an emergency contact person

to discuss treatment. If I am unreachable and my emergency contact is also unreachable my
veterinarian will be contacted (if they are available) and treatment will be discussed and agreed
upon.

I will be solely responsible for any charges incurred for any treatments and medications. If no
Emergency contact is listed please provide us with a hotel /resort name, or alternate number so
we can contact you to discuss emergency options.

Should any life threatening emergency arise, I authorize Diamond in the RUFF to determine the
need and to seek emergency services for my pet and make any needed decisions concerning life
threatening emergency treatment. Acushnet Animal Hospital will be the 1st choice, due to its
location, and after hours the Mass RI 24 Hour Emergency Hospital will be used.

I release Diamond in the RUFF and its agents from any liability for such medical emergency and
I will be solely responsible for any charges incurred for treatments and medications related to
said emergency. I also release Diamond in the RUFF from any liability for any injury incurred
during the transportation to and from the aforementioned Animal Hospitals.

We advise you to have a plan in place prior to your departure if traveling out of the country and
you are unreachable. Please talk to your veterinarian about having a payment on file for “in
case of emergency” . *Note* Most animal hospitals will not start any treatment without a
deposit in place. It is your responsibility to appoint an emergency contact who can be
responsible for such payment or contact your veterinarian or local 24 hour establishment and
leave a credit card on file while you are away. Diamond in the RUFF Spa LLC. is not responsible
for any deposits or payments in order for your pet to receive veterinary care. We advise you to
have an emergency plan in place prior to departure.

The dog owner, jointly and severally, agree to indemnify, defend, and hold harmless

Diamond in the RUFF spa, LLC, and its respective owners, representatives, agents, employees, attorneys, predecessors, successors, parents, subsidiaries, affiliates, and assigns, from any and all third-party claims, including but not limited to any claim by any person, executor, administrator, personal representative, or heirs of any Estate, concerning any and all claims, demands, damages, or causes of action relating to and/or arising out of the subject Agreement, and providing services to the dog owner's dog, and relating to any allegations and claims thereunder, allegations and claims that could be set forth in a legal proceeding.

Photo release:

Diamond in the RUFF Spa LLC. likes to take photos. We require acknowledgment by you, the pets owner that these photos may be used for business use, including but not limited to any advertising, newsletters, social media, brochures, photos in our shop etc. We will try, but cannot guarantee that we will be able to inform you that your pet is in a photo prior to use.

I understand that I will be charged for the day of entry.

Please schedule Drop off and pick up time at time of booking.

Diamond in the RUFF Spa LLC. is not responsible for loss or damage to any personal item belonging to your pet.

Boarding Deposits are non-refundable, non-transferable and non-exchangeable.
